About the Accredited Course.

Cottonsoft's Certificate courses are nationally registered through ANTA - (Australian National Training Authority) under the relevant Industry Training Authority.

Requirements

- A distance education course requires a competent level of reading and comprehension ability.
- You do need to have access to a Windows (XP or Vista) computer with Microsoft Office software (XP, 2003 or 2007) to complete this course.
- The Certificate III in IT course requires a number of Certificate II units as prerequisites. Your course package will include these basic units. However, you need to have competent basic computer skills to confidently undertake the course.

Refunds of Course Fees

Refunds of participant's fees will be made in accordance with our refund policy as set out below. Fees received prior to implementation of the course will be retained in a separate account until course delivery. *Fees will be assessed on the basis of the expected use of the course modules by an average participant.* Refund requirements are that if a participant cancels part way through a module, no refund should be made for this module but a full refund should be paid for the remaining modules.

In the event of:-

In the event of

- Cancellation of course by Cottonsoft Pty Ltd refund of course fees will be made in full.
- Cancellation of enrolment by a participant
 - ❖ Before course materials are sent or within the first week from despatch (if all materials are returned in unmarked condition), a full refund will be made.
 - ❖ After the first week but before 4 weeks from the course materials being dispatched, the refund will be the full course fees less a 20% administration fee and the value of the one third of the units in the course since it is assumed that you will have started these units.
 - ❖ After 4 weeks from course dispatch but before 16 weeks, the refund will be as above less a further reduction to cover another one third of the units.
 - ❖ After 16 weeks from course dispatch but before 26 weeks, the refund will be as above less a further reduction to cover the cost of units that have been supplied

Please note that the refund policies above are proscribed as the minimum requirement, at Cottonsoft we often extend these periods and offer refunds above the requirements.
